# Huntsville/Madison County Builders Foundation Scholarship Application

*The central object and purpose of the Huntsville/Madison County Builders Foundation shall be to engage in educational, charitable and scientific activities dedicated to the improvement of the residential housing industry and provision of housing for the public through educational, scientific, charitable and research efforts. To effectuate this object and purpose, the Foundation may present scholarships to those persons pursuing a level of higher education in a housing related field.*

## **GENERAL SCHOLARSHIP FUND**

### **I. Eligibility** - Scholarship recipients must:

- ◆ Be accepted by an accredited two year junior or community college, four year college or university, or state accredited vo-tech school; or an enrolled undergraduate student; and
- ◆ Be pursuing study in architecture, drafting, building science, civil engineering, or other housing industry vocations such as heating and air conditioning, electrical, masonry, carpentry, etc.; and
- ◆ Students must be residents of Madison County or contiguous counties.

**II. Selection** - Scholarships are awarded on the basis of academic excellence, service/activities, career goals, and financial need.

**III. Awards/Application** - Awards will be made by the selection committee pursuant to approval by the Foundation Board of Directors.

Foundation Scholarships shall be for one academic year and shall be in amounts determined by the Committee based on the recipient's financial situation, the relative costs of the schools involved and the amount of available funds. **The minimum funding shall be \$1,000.00 per award.**

Interested persons must fill out this application in its entirety and mail it to the H/MCB Foundation. Scholarship recipients will be announced at a general membership meeting of the Huntsville/Madison County Builders Association.

Scholarship Award letters will mailed to the educational institution no later than August 1st of the year presented. Note: Previous recipients must reapply each year.
